Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). Your email, dated 1st March 2021, asked for the following information:

The cost for operating the Construction Skills Network that will produce the forecast report for 2021 – 25 is £140,000. Due to COVID-19 and uncertainty with Brexit, we published a forecast summary in October 2020 with the full report due for publication during the spring / summer of 2021. In addition, the publication cost of the October summary report was £6,945.
